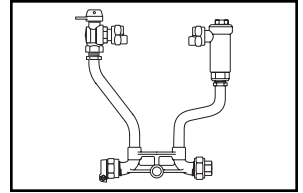


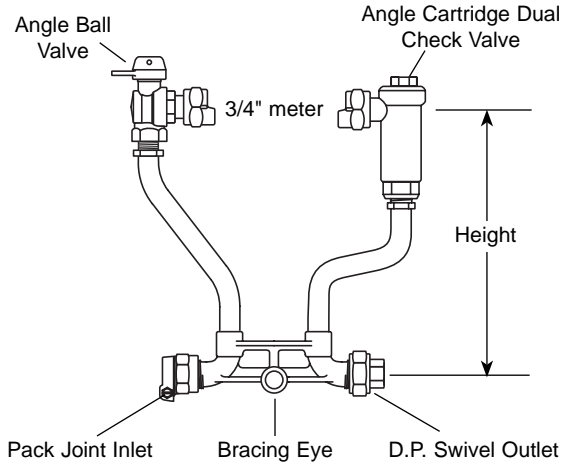

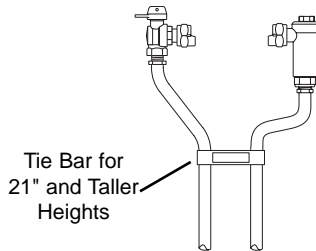
ANGLE BALL VALVE BY ANGLE CARTRIDGE DUAL CHECK VALVE (3/4" METER)
